Paying the CRA Online

Did you know that you can pay many of your government remittances online? Stop by the branch for assistance or follow the steps below.

Business Taxes

To pay GST, Corporation Tax, or Payroll and Source Deductions follow these steps.

1. Log into MemberDirect and select Payments
2. Pay Business Taxes
3. Select the appropriate type of payment and click Add Account
4. Once the Account is added click remit
5. Fill in the form shown and hit Submit

Personal Taxes

To pay Tax Installments, 2016 Tax Return, or tax owing follow these steps. Please note that this process can take 2-3 days to go through so don't wait until the last day to pay!

1. Log into MemberDirect and select Payments
2. Add Payee
3. Search CRA in the Payee Name
4. Select the appropriate payee
5. Enter your SIN as the account number and hit Submit
6. Pay as you would any other online bill.
